RESOLUTION

WHEREAS, on about February 8, 1979, Mitchell Engineering Company supplied a metal building to be known as the Fire and Safety Building for Pike Township, Clark County, Ohio, to the present site of Pike Township's Fire and Safety Building pursuant to a contract that Mitchell Engineering Company had with Jarmes, Inc., and

WHEREAS, said metal building cost \$22,963.36 and the Board of Trustees of Pike Township paid Jarmes, Inc. the sum of \$23,285.00 but Jarmes, Inc. failed to pay said sum of \$23,285.00 to Mitchell Engineering Company and thereafter Mitchell Engineering Company filed lien against the Public Funds of Pike Township in the amount of \$22,963.36, which lien was duly recorded in Volume 7, Page 584 of the Mechanics Liens Records of Clark County, Ohio, and

WHEREAS, on December 4, 1985, Judge Gerald F. Lorig of the Common Pleas Court of Clark County, Ohio, rendered a Judgment in favor of Mitchell Engineering Company against Pike Township, Clark County, Ohio, in the amount of \$22,963.36, together with interest thereon at the legal rate from and after April 17, 1979, as a result of the use of said metal building by Pike Township and

WHEREAS, Mitchell Engineering Company has agreed to waive said interest if Pike Township would not appeal the Decision of Judge Gerald F. Lorig to the Court of Appeals of Clark County, Ohio, and

WHEREAS, the Board of Trustees of Pike Township, Clark County, Ohio, desires to comply with the Decision of Judge Gerald F. Lorig and has decided that it would be to the best interest of the citizens of Pike Township, Clark County, Ohio, to set aside said Judgment and to terminate further legal proceedings regarding said matter.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Pike Township, Clark County, Ohio, that said Board of Trustees of Pike Township, Clark County, Ohio, does hereby authorize the payment of \$22,963.36 to Mitchell Engineering Company out of the proceeds of the Fund which resulted from a levy passed by the citizens of Pike Township, Clark County, Ohio, which said Fund has heretofore been deposited and held in Escrow in a financial institution in Clark County, Ohio, in order to satisfy any Judgment which might have been entered against said Pike Township as a result of pending litigation in Case No. 79-CIV-1366, Common Pleas Court of Clark County, Ohio.

BE IT FURTHER RESOLVED that the Treasurer of Pike Township, Clark County, Ohio, be and he is hereby authorized and directed to issue a draft in the amount of \$22,963.36

against said Fund which has been deposited in an Escrow Account in a financial institution in Clark County, Ohio, payable to Mitchell Engineering Company.

The three members of the Board of Trustees of Pike Township, Clark County, Ohio, unanimously approved the foregoing Resolution at a regular meeting held by said Board of Trustees on the 31 day of January, 1986.






